In January 1990 the OHS services of the DIRE were amalgamated with the State Compensation Board (as recommended by the Prevention Programs Branch) to form the WorkCover Authority.

For three years, commencing in 1980, I served on the national executive of the Federation of Australian University Staff Associations. I was closely involved in the early implementation of tertiary sector policy and practice on equal employment opportunity and childcare provision.

Since joining the Faculty of Health Sciences at Sydney University in 1995 I have made submissions to relevant Commonwealth, State and industry inquiries dealing with health, sustainable development and related matters. My aim generally has been to promote understanding of the importance and role of a risk management approach, in the context of the issues under inquiry.
